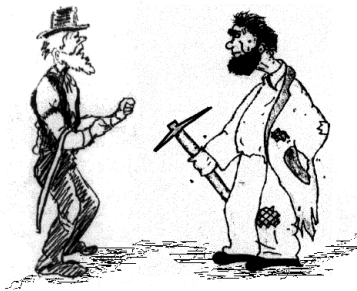

- Setup time begins at noon on Friday (before the parade) and 8 am on Saturday.
- All concessionaires must stay until 6 pm on Saturday.
- Concessionaires may stay until 11 pm (festival closing)—no vehicles in the festival area until after 11 (you may hand carry out your booth and supplies before that time).
- Concessionaire is responsible for clean up around space upon closing.
- Reserved parking area for concessionaires.

Friday evening parade is a HUGE draw—and lots of activities are planned all day on Saturday. Free entertainment throughout both days.

Festival T-shirts, hats and local building replicas will be on sale at the information booth.

50/50 tickets will be on sale at the information booth

As a token of our appreciation, each concessionaire will receive two tickets redeemable for a free cup of coffee or pop.

Reservation for space needs to be confirmed by July 1st

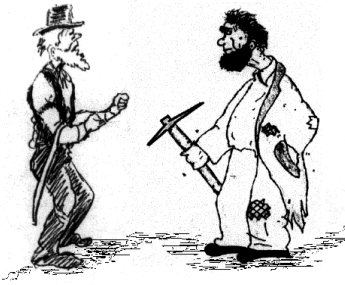

- **‘Grey water’ dump station to be provided—grey water cannot be off-loaded into the storm sewers**

*Alternative trailer sizes need to be arranged for in advance—different rates may be applicable)
