LOOKING AHEAD IN 2026 & BEYOND

As we move through 2026, I'd like to share a look at some of the projects and initiatives currently underway or planned for this year. This update focuses on what lies ahead and how we are continuing to invest in Doylestown's infrastructure, operations, and community experience.

Water & Utility Infrastructure

This year, our **elevated water storage tanks (water towers)** will undergo scheduled cleaning and maintenance to protect water quality and extend the life of these critical assets.

We are also launching our phased **water meter replacement program**, which will occur over the next four years. During this process, we will be validating our lead service line inventory in compliance with state and federal requirements.

In addition, the Water Department will begin tracking the condition of all valves and public water lines in our ArcGIS software as part of our long-term Asset Management Program. This data-driven approach helps us prioritize maintenance and responsibly plan future capital improvements.

On the wastewater side, we will complete the **Collier Lift Station upgrade** and outfit both the water and sewer departments with additional camera equipment to improve inspections, diagnostics, and operational efficiency.

New Street Department Facilities

Construction will begin on the new Street Department Facilities next to the sewer plant on Calaboone Road. This facility will improve equipment storage, protect Village assets, and enhance operational readiness for road and storm infrastructure maintenance.

Road Maintenance Program

We will be chip sealing several Village streets this year as part of our pavement preservation strategy. Our goal is to proactively maintain asphalt roads so that, moving forward, only our concrete streets remain for major maintenance planning in upcoming fiscal years.

Preventative maintenance today helps us avoid significantly higher reconstruction costs tomorrow.

Cemetery Improvements

Improvements at Chestnut Hill Cemetery this year include:

- Additional parking spaces
- Installation of our first columbarium for cremated remains
- Development of an open-air chapel space for services

With the development of our open-air chapel, graveside services will be held at the chapel only for safety reasons. These additions expand options for families while maintaining the character and dignity of the cemetery.

Memorial Park Improvements – Community Fundraiser

We continue working toward enhancements at Memorial Park, including:

- A walking path connecting the pavilions
- Restroom renovations
- Installation of a security camera system

This is a community-supported project, and we sincerely appreciate everyone willing and able to contribute.

Technology, Efficiency & Community Planning

Across departments, we are continuing efforts to modernize and improve efficiency:

- The Zoning Department is updating and cleaning up official zoning maps to reflect previously approved changes, ensuring accuracy and consistency.
- Tablets will be rolled out to several departments to allow staff to access maps, software and records in the field.
- The Fiscal Office is implementing expanded online payment processing for pavilion rentals, Gene Daniels Community Center reservations, donations, contractor registrations, and other Village transactions.
- The Police Department will be pursuing grant funding to transition to a secure cloud-hosted server environment to strengthen cybersecurity and data resilience.
- We are also working to **re-establish the Village's Economic Development Committee** to help support local business growth, strategic planning, and long-term community vitality.

Preparing for the 2027 Bicentennial

Planning continues for Doylestown's 200th Bicentennial Celebration in 2027. We are preparing for:

- 12 months of community events
- Opening the 1977 time capsule
- Closing a new 2077 time capsule
- Publishing a commemorative book highlighting 200 years of progress, with special emphasis on the past 25 years

Looking Ahead

The items listed above represent just a portion of the projects and improvements underway this year. From infrastructure maintenance and technology upgrades to community planning and economic development, our focus remains on responsible stewardship, proactive maintenance, and preparing Doylestown for the future.

FROM THE ZONING DEPARTMENT

Updated Grass & Weed Enforcement Procedures

The Village Council has approved updated procedures for enforcing high grass and weed violations to help maintain neighborhood appearance and promote safe, healthy property conditions throughout the growing season. Under the revised regulations, grass and weeds may not exceed 8 inches in height on any property within the Village. When a violation is observed, a notice will be posted directly on the property. Property owners now have **48 hours from the time of posting to correct the issue**. Additionally, only one notice per season is required for continued compliance.

If the violation is not resolved within the 48-hour window, the Village may proceed with mowing the property. The cost of this service, along with applicable administrative fees, will be billed to the property owner. Unpaid charges may also be assessed as a lien on the property taxes. Property owners who receive an invoice and believe it was issued in error may submit a dispute within 30 days of receiving the bill.

As we head into the growing season, residents are encouraged to regularly maintain their lawns to avoid violations and help keep our community looking its best.

Brush Pick Up Resumes

Brush pick up is held on the second Monday of each month from now until October. Pick up dates are: **April 13, May 11, June 8, July 13, August 10 and September 14 (last pick up of the year)**. Please note that weather may cause a delay on any of these regularly scheduled dates. Depending on the amount of brush around town, it may take more than one day to collect. The crew will only go through each neighborhood one time, **please have your brush to the curb by 8 am on the scheduled pick up date.**

PLEASE FOLLOW THESE RULES:

Each residence is allocated a maximum of 15 minutes worth of brush for disposal. Brush also needs to be stacked with branch ends all one direction. Do not mix leaves and brush as there are separate machines that handle this. Only brush can be picked up during this time. Thank you, from the Street Department.

GOODWILL DROP-OFFS RESUME



Goodwill will return to Village Hall for donations on the **second Saturday** of each month. The truck will be here from 10:00 am to 2:00 pm. **NO donations are to be left in the parking lot if the truck is gone.**

Village-Wide Multiple Large Item Pick-Up Dates

APRIL 10 & OCTOBER 9

- * All upholstered items and mattresses must always be wrapped in plastic.
- * Appliances with freon must be removed and red-tagged by a certified technician.
- * Items not able to be bagged must be under 4 feet in length and weigh less than 50 pounds.

The following items are NOT accepted:

Appliances containing freon, air conditioners, dehumidifiers, hazardous or toxic wastes, oil, auto parts, batteries, steel drums, ashes, liquids, paint, tires, computer monitors, material containing asbestos, infections or biohazardous waste, concrete, stones, dirt, sand, brick, construction materials, demolition materials, fluorescent bulbs, gas cans or any other flammable and/or combustible materials. **Services are provided by Kimble**

All Christmas and seasonal decorations must be removed by **April 1st** each year. Items left after this date may be cleared during regular maintenance.

2026 Cemetery Cleanup & Maintenance

The Village will conduct a phased cleanup at Chestnut Hill Cemetery throughout 2026 to improve maintenance and comply with regulations.

- No items on the **back or sides** of headstones
- Front items must be within **12 inches** of the headstone

If you have non-compliant decorations or plantings you wish to keep, please remove them by **May 31, 2026**. Remaining items may be relocated near the soil piles on the cemetery's northwest side.

Village Electric Aggregation Program Update



The Village's current electric aggregation program will end in **May 2026**. We are pleased to announce that we have secured a **new 19 month agreement** with **Direct Energy**, offering a fixed rate of **\$0.0999 per kWh**. This new rate will take effect beginning with your **June 2026** billing cycle and will remain in place through **December 2027**.

This is an **opt-out program**, meaning all eligible residents are automatically enrolled unless they choose **not** to participate.
