ALL PRIVATE SNOW REMOVAL FIRMS AND INDIVIDUALS SHALL REGISTER ANNUALLY WITH THE VILLAGE OF DOYLESTOWN IN ACCORD WITH THE PROVISIONS SECTION 5, HEREIN, PRIOR TO REMOVING, PUSHING OR PLOWING SNOW FROM ANY PRIVATE OR PUBLIC PROPERTY LOCATED WITHIN THE VIILLAGE. **SUCH REGISTRATION WILL EXPIRE ANNUALLY ON JUNE 1 OF EACH YEAR.**

REGISTRATION PROCEDURE (ORD. 2009-28 SECTION 5)

The Village of Doylestown shall register and issue sticker registration tags to all firms or individuals who:

- (a) Complete an application from prescribed by the Village of Doylestown for registration of private snow removal firms and individuals;
- (b) Pay a registration fee of ten dollars (\$10.00) per year;
- (c) Demonstrate proof of commercial or for hire liability insurance with limits in the amount of fifty thousand dollars (\$50,000) per person and one hundred thousand dollars (\$100,000) per occurrence for bodily injury and fifty thousand (\$50,000) property damage liability.
