RE: EXTENSION OF CONTRACT FOR WEEKLY TRASH REMOVAL - REVISED

Dear Mr. Lindeman:

Kimble Recycling & Disposal, Inc., ("Kimble") is pleased to provide the Village of Doylestown ("Community") with the following proposed Extension Agreement for the extension of our existing Contract:

WHEREAS, Kimble and the Community originally entered into an agreement for the collection and disposal of Solid Waste on April 1, 2022 (hereinafter "Contract"); and

WHEREAS, the Contract will expire on March 31, 2025, and the Community desires to extend the existing term of the Contract until March 31, 2027 as provided herein; and

WHEREAS, the parties acknowledge the disposal of residential refuse within the Community is a matter of public safety and public health and that this Extension Agreement is necessary to preserve said public health and safety.

NOW THEREFORE, in consideration of the promises and mutual covenants contained herein and, in the Contract, the parties agree as follows:

1. All the terms, conditions, exhibits, attachments and provisions contained in the Contract are hereby incorporated by reference and shall continue in full force and effect, the same as if they were set forth herein verbatim, except the following terms which shall supersede any conflicting terms in the Contract:

a. **Extended Term.** The Contract shall be amended to provide for the term of the Contract to be extended until March 31, 2027 ("Extended Term");

b. **Price.**

Year 1: The Contract shall be amended to provide that the price for services during the first year of the Extended Term shall be \$19.39/month for full-service and \$4.00/bag for low volume residents. Low volume residents can add recycling for \$7.35/month. The price for rental of an extra 95-gallon refuse cart during the extended term shall be \$3.50/month and an extra 65-gallon recycling cart shall be \$3.25/month. Business customers within the Village who wish to contract with Kimble for trash

removal service at a cost of **\$89.00/month** (2yd container 1x per week).

Year 2: The Contract shall be amended to provide that the price for services during the second year of the Extended Term shall be **\$19.97/month** for full-service and **\$4.25/bag** for low volume residents. Low volume residents can add recycling for **\$7.60/month**. The price for rental of an extra 95-gallon refuse cart during the extended term shall be **\$3.50/month** and an extra 65-gallon recycling cart shall be **\$3.25/month**. Business customers within the Village who wish to contract with Kimble for trash removal service at a cost of **\$94.00/month** (2yd container 1x per week).

Included:

Village Hall, 2yd and recycle cart serviced 1x per week
Street Dept, 2yd serviced 1x per week
Chestnut Hill Cemetery, 2yd serviced 1x per week
Chippewa Twp FD, 2yd serviced 1x per week
Sewer Plant #1, 2yd serviced 1x per week
Gene Daniel Park, 2 – 4yds serviced 1x per week
Sewer Plant #2, 6yd serviced 1x per week
Police Station, recycle cart serviced 1x per week
City Cans, ~~12~~ serviced 1x per week
Rouges Hollow Festival, 40yd OT
Spring and Fall Curbside Cleanup (same day as service day)

- c. **Terms.** All other terms of the Contract not modified herein shall remain binding on the parties during the original term and the Extended Term.
2. All recitals to this Extension Agreement are hereby incorporated by reference and made a part of this Extension Agreement.
 3. There are no other terms and conditions governing the matters herein addressed except those expressly contained herein.
 4. All defined terms not otherwise defined in this Extension Agreement shall have the meaning set forth in the Contract.
