**KNOW ALL MEN BY THESE PRESENTS:**

**CONDITION OF THIS OBLIGATION:**

WHEREAS, the Principal has applied for a permit to perform work within the Village's public right-of-way, as authorized under Section 905.04 of the Village of Doylestown Code of Ordinances; and

WHEREAS, the Principal is required to furnish a bond guaranteeing:

1. Completion of the work in accordance with Village standards and approved plans;
2. Proper restoration of any disturbed pavement, curb, sidewalk, landscaping, or other improvements; and
3. Correction of any defects arising within one (1) year of completion.

NOW, THEREFORE, if the principal shall faithfully perform said work and fully restore all disturbed public property to the satisfaction of the Village, then this obligation shall be null and void; otherwise, it shall remain in full force and effect.

The Surety may cancel this bond by giving thirty (30) days' written notice to the Village, but such cancellation shall not affect any liability accrued prior to the effective date of cancellation.
